- Development Order Amendment Report-** contains a consistency assessment with the Council's Notice of Proposed Change Report and the Development Order Amendment.
- Development Order Report -** contains consistency assessment between the Council's *Final Report* and the Development Order.
- Final Report -** contains detailed project development information and a summary of all anticipated impacts and recommended mitigative measures (regional conditions) necessary to minimize or offset these impacts.
- Notice of Proposed Change Report -** contains a summary of proposed development changes and identification of recommended Development Order Conditions to offset the additional regional impacts anticipated from the proposed modification(s), if applicable.
- Preapplication Conference Report -** contains introductory information about the proposed development and a summarized listing of all regional issues in which the developer must provide responses throughout the duration of the DRI review process.
