6. **A. Skyway ConneXion** - Mr. Ryan Suarez, Planning Manager, Manatee County Transit Division

In 2016, Manatee County Area Transit (MCAT) began operating a new inter-county limited stop, express service, the *Skyway ConneXion*, connecting Manatee and Pinellas County. The service connects the three major Manatee County Transfer Stations (DeSoto, Downtown Bradenton and Palmetto Stations) with stops in Pinellas County that include 54th Avenue South, the Pinellas Suncoast Transit Authority (PSTA) Grand Central Terminal, PSTA's Tyrone Square Mall transit center and the C.W. Bill Young/Bay Pines Veterans Administration (VA) Hospital, which is also served by PSTA fixed route buses. The project was this year's winner in the Transportation and Mobility category of the Annual Future of the Region Awards. Mr. Suarez will provide an overview of the project.

D. **Emergency Management and Hazard Mitigation**

Recently, a couple of articles in local and national media have shone a spotlight on weather and climate issues in the Tampa Bay area. On July 28, 2017, the *Washington Post* published a story titled "Tampa Bay's Coming Storm" by reporter Darryl Fears. The story and accompanying videos chronicle the region's vulnerability to hurricanes and flooding, which may be exacerbated by sea level rise in coming decades. In his story, Fears highlights the plausible, but very low-probability, worst-case hurricane scenario for Tampa Bay, known as "Hurricane Phoenix." The Hurricane Phoenix scenario was developed for TBRPC's "Tampa Bay Catastrophic Plan" in 2010. The *Washington Post* article, "Tampa Bay's Coming Storm," may be accessed online here:

Director's Report August 14th, 2017 Meeting

TBRPC Efforts

- *On July 28th the Council was recognized by the Washington Post for your work on the potential impacts to the region if a Category 5 Hurricane was to make landfall in the region. You may recall we played this video at a Council meeting last year. We received numerous inquiries including CBS news after this story ran.*
- *On June 15th staff attended a meeting at the Hillsborough Environmental Protection Commission to celebrate a 50 year anniversary of the success of this organization. EPC representatives will be asked to address the Council at a future meeting to describe Hillsborough's efforts as a steward of the environment.*
- *Also on June 15th staff Planner John Myer participated in a Florida Department of Health Point of Distribution training exercise in Hernando County as part of his duties as manager of the Local Emergency Planning Committee.*
- *On June 22nd I met with Jerry Custin Executive Director of the Upper Tampa Bay Chamber of Commerce in Oldsmar to discuss possible collaboration on projects of mutual interest.*
- *On June 28th I attended the Clearwater Chamber of Commerce annual Legislative Delegation breakfast to network and learn about legislation that was passed in the recent Session and the impact of legislation on the Tampa Bay Region.*
- *On June 29th I attended the Florida Regional Council's Association Policy Board meetings along with Council Member Barbara Sheen Todd. The Association elected a new slate of officers and we remain fortunate that Council member Todd will remain on the Executive Board as the immediate past President. Thanks to Ms. Todd the Association has a new website, logo, a renewed*

relationship with the Florida Association of Counties and a newsletter that is distributed to over 2500 people on a monthly basis.

- *Staff submitted two grant applications to the State Department of Economic Opportunity. One grant was to continue our storm surge modeling efforts and the second grant seeks funding to develop a land re-use plan in Citrus County.*
- *On July 20th staff IT Director Marshall Flynn and Planning Technician Brian Ellis attended a ribbon cutting for the expansion of the Coast to Coast trail network in Tarpon Springs. The TBRPC has been an active participant in the planning phase of the Coast to Coast trail and assisted with plan design and logo branding efforts. TBRPC received two grants from the Florida Department of Economic Opportunity to conduct a technical assessment and modeling for the trail.*
- *On July 21st staff attended and coordinated a meeting of the Courtney Campbell Causeway Scenic Highway Advisory Committee in Tampa. The TBRPC staffs this committee to ensure that the Causeway maintains its designation as a Scenic Highway.*
- *On August 1st and on each consecutive Tuesday in August thereafter, TBRPC staff will be attending public meetings in the City of Tampa in concert with FDOT to present the first phase of an economic impact analysis of the proposed Tampa Bay Next surface transportation project. We anticipate the full analysis to be complete by the end of the year.*
- *On July 21st I participated in a conference call with the National Association of Regional Councils to discuss potential improvements to USDOT transportation policies. NARC drafted a non-partisan letter to DOT with input from the TBRPC and RPC's throughout the Country that will assist Regional Council's with navigating Federal Highway and Federal Transit regulations. Ex. NEPA, Performance Measures, Civil Rights.*
- *On July 26th Planning Technician Brian Ellis and I met with Derryl O'Neal, acting City Manager for the City of Madeira Beach to discuss services offered by the TBRPC and indicated that the Council looks forward to working with the City, the most recent community to join the Council. Wren and Brian followed up with a presentation to the City Commission on August 8th.*
- *On July 31st Wren attended a Florida Public Human Resources Conference in Orlando to enhance her knowledge of ever changing personnel regulations.*
- *On August 2nd I met with Pinellas Park City Manager Doug Lewis to discuss services offered by the TBRPC and to learn more about opportunities of collaborating with the City. The meeting was very productive and we look forward to continuing to work with the City.*
- *On August 7th & 8th we collaborated with the National Oceanic and Atmospheric Administration to host a climate change workshop on adaptation planning for coastal communities. This workshop was open to all 27 member governments in our region. Environmental Planner Heather Young coordinated this effort.*
- *On August 9th I attended a Legislative Chamber Luncheon at the Upper Tampa Bay Chamber of Commerce. Several Legislators attended this meeting to discuss recent actions taken in the 2017 Session.*
- *Also on August 9th I met with new Pasco County Administrator Dan Biles. Mr. Biles comes to Pasco County via Alabama where he served as Deputy Manager in Jefferson County. We discussed the long standing relationship that the TBRPC has had with the County and the services offered by the TBRPC. We look forward to maintaining and strengthening our relationship with Pasco County.*
