

## NOTICE OF PUBLIC MEETINGS

The Federal Emergency Management Agency (FEMA), part of the Department of Homeland Security, is reviewing Manatee County's plans for utilizing funds in the event of Presidential declared disasters, such as Tropical Storm Gabrielle. The Local Mitigation Strategy (LMS) is a plan that contains project initiatives that mitigate the adverse effects of future disasters. After the President declares a disaster area a portion of the funds are made available for hazard mitigation grants in response to a disaster. The LMS guides the allocation of those funds to various projects. The LMS will be available for the public to review at the following Evaluation and Appraisal Report workshops.
