1. Bill Jonson called the meeting to order at 10:02 AM. Introductions were made.
2. Public Comment: None.
3. Meeting Summary: Upon a motion by Mr. Gregory and seconded by Mr. Coleman, the meeting summary was unanimously approved.
4. FDOT Landscaping Plan (Pinellas) - Currently at 60% design. Clearwater does not want date palms. To be replaced with sabal palms. Washingtonian and mule palms are infected (3 diseases) on the Hillsborough side (21-22%). Phase 4 plans to be submitted on December 15. Contract awarded in May 2016.
5. Pinellas Trail Head - FDOT Construction Office to be vacated within a year. FDEP surplus potential. Still pursuing a sublease from FDOT. Wants a letter from the CAC to the FDOT Secretary making the request to sub-lease. Bill McTear. Upon a motion by Ron, seconded by Mike, Bill will write a letter on behalf of the CCCSH CAC requesting information from FDOT on the potential sub-lease of the construction office. Chamber of Commerce has expressed an interest in restoring the visitor center on or near the subject property. FDOT extended the guardrail to Bayshore in response to request from City of Clearwater.
6. Amenities Funding Request to Pinellas County - Request should be submitted to County Administrator. Susan will follow-up to be sure that is the right person.
7. Coastal Cleanup - KTBB event on September 19 and KPB events in October. Committee members were curious about why the affiliates can't work together to clean the whole scenic byway at once.
8. Other Items:
