CONCEPT AND DESIGN

Purpose

On August 24, 1992 Hurricane Andrew devastated southern Dade County with the worst natural disaster to strike the United States. The personnel of Miami-Dade County Fire Rescue responded rapidly and tirelessly in assisting the citizens of these communities. Numerous fire-rescue agencies from across the State of Florida and the nation assisted in this valiant effort. It became abundantly clear from the disaster, and the ensuing relief effort which followed, that greater coordination for inter-agency disaster management was required.

The purpose of the Florida Fire Chiefs' Association's (FFCA) Statewide Emergency Response Plan (SERP) is to provide such coordination. It is based on a series of observed occurrences resulting from the shared experiences during Hurricane Andrew. It is also an evolution of our past experiences in dealing with the day-to-day incidents that continually challenge our resources and competencies. Most importantly, it is a practical approach in providing a useful guide to assist the fire service in managing the types of devastation that occur in the state.

The Florida Fire Chiefs' Association created the FFCA SERP to provide for the systematic mobilization, deployment, organization, and management of emergency resources throughout Florida, and the nation and to assist local agencies in mitigating the effects of emergencies and disasters. The local fire-rescue agency is the first tier of defense in responding to natural and man-made disasters (emergencies). The primary function of fire-rescue personnel in the wake of a disaster is to conduct search and rescue activities, treat the injured, and transport them to the closest available medical facility. No community has sufficient resources to cope with all emergencies.

Florida's large and rapidly growing population centers are located in regions susceptible to hurricanes, tornadoes, and flooding. This accentuates the need for this level of coordination and preparation. The effective management of emergency response personnel during the incipient stage of any major incident and throughout its extended operations, will, by far, have the most significant impact on loss of life and the severity of injuries to the affected population. The FFCA SERP lends itself to the rapid activation and response of aid to a community in the event of localized all-hazard emergencies. These events include train derailments, hazardous materials incidents, wildland fires, domestic terrorism and other events that may overwhelm the department serving the community and its normal mutual aid resources.

Coordination of the FFCA SERP

The coordination of the SERP, including its development, revision, distribution, training and implementation is the responsibility of the Florida Fire Chiefs' Association. The FFCA Emergency Response Committee will oversee this process. The committee is composed of the following:

- Florida Association of Emergency Vehicle Technicians (FAEVT)

Structure

In accordance with Homeland Security Presidential Directive HSPD-5, which established the National Incident Management System (NIMS) to coordinate all Federal, State, local and private industry preparedness and response to incidents, and under the guidance of the National Response Framework (NRF), all domestic emergency management operations will be conducted under the Incident Command Structure (ICS) set forth by NIMS. Within the ICS, the prescribed duties of all Public Information Officers are set to serve in a Command Staff position reporting directly to the Incident Commander or an assigned designee for the purpose of establishing and maintaining the flow of information to internal and external stakeholders, including the media or other organizations seeking information from the incident or event.

The emergency management structure in the State of Florida is guided by Florida Statute Chapter 252 and sets up a structure, which has four levels of intervention (local, county, state and federal). The basic concept of the SERP is the lowest level of government shall have initial responsibility for emergency response and relief, attempting to mitigate the situation with the resources available at that level. Requests for assistance from the next higher level of government will be made when the magnitude of the disaster either exceeds the resources of the local level of government or the resources needed are not available at the local level.

Under Chapter 252, each county government is to operate an emergency management agency for the purpose of coordinating disaster relief efforts in the county. Upon

exhausting of resources at the county level, requests for State assistance will be made to the Florida Division of Emergency Management (DEM). Rapid Impact Assessment Teams (RIAT) will be sent to evaluate the damage and the assistance needed through the State. Based on this or other information, the Governor may declare a “state of emergency,” and direct state resources into the affected area. The State Emergency Operation Center (EOC) would be activated at this time and will provide direct liaison to the County EOC regarding the coordination of state resources operating and/or responding into the affected area.

State agencies will provide resources to local government according to the functional responsibilities outlined in the Statewide Emergency Response Plan. These functions are referred to as Emergency Support Functions (ESF). For each function, a designated State agency will have primary responsibility and will provide resources and leadership relating to that function.

When local and state resources are determined to be inadequate to respond to the emergency, the Governor will request assistance through the Federal Emergency Management Agency (FEMA). The requests will be based on state and local damage reports and expenditure reports for disaster-related activities. When the President of the United States declares an emergency area as a major disaster, federal assistance would then be authorized to assist State government. In Florida, the DEM has been designated as the state agency responsible for coordinating assistance received through federal programs.

Emergency Support Functions (ESF)

**** NOTE:** It is important that all deployment team members remain aware that the Emergency Support Functions under the Florida SERP are slightly different than those under the National Response Framework (NRF). Until otherwise notified that the requisite changes have been made to reflect the ESF designations listed under the NRF, the following SERP designations will apply:

PIO DEPLOYMENT TEAM

FAPIO Statement

It is the statement of the Florida Association of Public Information Officers (FAPIO) that if called upon for deployment under the Division of Emergency Management State PIO Deployment Team, that the following objectives be accomplished in the most efficient manner possible.

1. The public affected in the disaster area shall receive the most accurate and timely information about conditions in their area.
2. All media personnel will be treated fairly and equally.
3. The Florida Association of Public Information Officers (FAPIO), Florida Fire Chiefs' Association (FFCA) and the State of Florida Division Emergency Management (DEM) will be represented in a professional manner at all times during deployment.

Team Membership

1. The State PIO Deployment Team is made up of public information officers with emergency agencies within the State of Florida. These team members must have completed a county, state or federal course for public information officers; must provide certificate of completion for NIMS/ICS courses IS700, IS702, IS100, IS200, IS300 and IS400; and be a member of FAPIO. All team members are strongly encouraged to become a FEMA Type-1 Advanced PIO by taking the DHS/FEMA Advanced Public Information course. Until a Type-1 designation becomes applicable, team members will serve as Type-2 or Type-3 support within the Joint Information operation(s).
2. The PIO Deployment Team roster will be made available and maintained by the State PIO Deployment Team Coordinator and the Alternate Team Coordinator.
3. Public Information Officers wishing to serve on the team will complete and submit an application to the State PIO Deployment Team Coordinator and the FAPIO Executive Board for approval.
4. Deployment team members will update contact information with the Deployment Team Coordinator. Team members will have a minimum of two ways of being contacted for deployment. This information will be updated annually and is confidential. The member must agree to answer their phone and respond in a timely manner to report deployable status when called for duty activation.

5. All Deployment Team members will submit the official "Deployment Letter of Understanding" signed by the team member's supervisor, on an annual basis, providing mutual understanding of the deployment process, potential length of absence, and home agency permission to deploy with minimal notice.

Type-1 Advanced PIO

To become a Type-1 Deployment Team Lead PIO, a member must be in good standing for one year, must have been deployed to an incident, and must complete DHS/FEMA Advanced PIO course (B388) to secure Type-1 status. The lead PIO will be responsible for the deployed team during activation, will report directly to the incumbent PIO and local Incident Command, will report activity and status to the Deployment Team Coordinator and State EOC, and will be responsible for managing the team's ICS-214 forms.

Type-2 PIO

Deployment Team members who are not a Type-1 APIO will serve on the team as additional PIOs for the Lead PIO and/or local incumbent PIO as needed and assigned.

Type-3 PIO

Type-3 PIO will serve as administrative support personnel in the Joint Information Center (JIC) as needed and assigned.

Preparation for Deployment

Team members will be prepared for deployment at all times and will have supplies to be self-sufficient for a minimum of 7 days. It is important to maintain the following items in readiness:

working clothes (FAPIO, SERT shirts)	non-perishable food and water
personal hygiene items	manual can opener
note pads	first aid kit
pencils	insect repellent
pens	sunscreen
highlighters	sleeping bag, pillow, blanket
push pins	cooler
35mm/digital camera	medications
film	flashlight with extra batteries
cassette recorder, batteries, tapes	eye glasses/sunglasses
cell phone with charger	
laptop computer with charger and printer with paper (TAC Pack)	
structural or wildland firefighting gear, if possible/necessary	

agency vehicle or other means of transportation.

Activation

A request will be made from a county EOC or DEM official for a Public Information Officer (PIO). The request will be taken at the State EOC and forwarded to ESF 4 & 9 and ESF 14. The following explains the flow of notification:

1. ESF 4 & 9 and ESF 14 will notify the PIO Deployment Team Coordinator.
2. Information will be obtained on type of emergency, emergency incident location, deployment duration, name of reporting supervisor, number of PIOs needed and state tasking number. (Example: FFC/03/001/001)
3. If the request is for more than one PIO, a team leader must be deployed.
4. Deployment team members who are located in the same region as the emergency will be contact first, due to response time.
5. When team members accept the assignment, all information regarding the deployment will be given including the state tasking number. Tasking numbers are necessary for accountability and reimbursement. **You and/or your home agency will NOT receive reimbursement without a Tasking Number!**
6. Once a team member has accepted the assignment, the Deployment Coordinator will notify the state official that made the request, ESF 14 and the Regional Coordinator of the team member's home base.

Time Frame for Deployment

Upon being notified of a deployment, the team member must accept or deny the task. Unless specified otherwise at the time of request, the standard time frame for deployment is two (2) hours from the mission assignment from the State EOC. Under certain circumstances a more rapid deployment may be deemed necessary by the State EOC and authorized as a "Rapid Activation". Time frame for this deployment is one (1) hour. Team members should be prepared to exist in a self-sufficient environment for a minimum of seven (7) days and possibly up to two (2) weeks per deployment.

Arriving at Deployment Destination

- You may be deployed to one of the following areas: Field Incident Command Center, County Emergency Operation Center or State Emergency Operation Center.
- Immediately upon arrival you will register at the designated "Check-in" table. Under ICS, Check-in may be found at several incident facilities including:
 - Incident Command Post
 - Base or Camp(s)
 - Staging Areas
 - Helibase
 - Division/Group Supervisor (for direct assignment)

Upon arrival, state your name, that you are a member of the State PIO Deployment Team and your tasking number. Establish the current "Branch in Authority" (Fire, Law Enforcement, Health, Federal, State or Local, etc.) for your assigned Operational Period.

- Once you have registered at your destination, you must report to the Incident Commander per NIMS/ICS and you will serve in a Command Staff capacity as assigned by IC and/or the incumbent PIO. In the event that there is no incumbent PIO present, the Deployment Team Lead PIO will assume the position.
- Team members will establish a Joint Information Center (JIC) within or in reasonable proximity to the Incident Command Post. If proximity becomes an issue, an assistant may be needed to serve as a "runner" between the JIC and the ICP. If a Deployment Team Tac Pack is not available for use, the team will obtain equipment necessary to complete the mission (radio, fax, computer, etc.) per JIC Guidelines and listed above in the "Preparation for Deployment" section.

Field Procedures

- Deployment Team members will act as assisting PIOs to the agency in charge. If there is no incumbent local PIO then the deployed Type-1 PIO will assume the Lead PIO duties.
- The deployment Lead PIO will attend all IC briefings, evaluate the emergency incident and coordinate work assignments for team members. While working on assignments, team members must use time wisely and schedule sleep and rest periods. All team members will evaluate if additional PIOs will be needed for relief. **The IC will need to approve additional PIOs, and a new tasking assignment and number will be needed.**

- Team members will make contact with their supervisor (IC, CEM, etc.) or assigned logistics officer regarding sleeping arrangements (hotel, tent).

Daily Assignments

- Team members must maintain a record of hours worked, daily activities and assignments. This information will be tracked on ICS Form 214 (attached) and submitted daily to your lead PIO, Team Leader, IC, CEM or Plans Officer.
- Deployment team members will coordinate the following tasks:
 - release of information
 - news releases
 - media briefings
 - news conferences
 - interviews
 - media pools
 - escort for VIPs
- The Lead PIO will attend all incident command briefings and planning meetings.
- **Approval must be gained from the IC or CEM before information is released to the media.** Copies of all releases will be posted at the Incident Information Center and at Incident Command. Releases will be faxed or e-mailed to ESF 14 Desk at the State EOC.
- The deployed Team Leader will make contact with the ESF 14 Desk daily by phone or e-mail and submit their daily activity. They will make contact with the State Deployment Coordinator every other day for briefings.
- Team members shall check in and out each day through the Incident Operations Section for accountability.

When your Assignment is Complete

- When your deployment task is completed and the IC or CEM is ready to release you, you must contact the ESF 14 Desk at the State EOC and the State Deployment Coordinator.
- **If your current task ending date has arrived and the IC or CEM still needs your assistance, a new tasking number must be requested for your new assignment.** The State EOC may assign a new tasking number or extend your current tasking date. You must notify the ESF14 Desk at the State EOC and the State Deployment Coordinator. **Remember: NO NEW TASKING NUMBER, NO REIMBURSEMENT FOR YOUR HOME AGENCY!**

SPECIAL ASSIGNMENTS

Guidelines for Interviews

- Be prepared, gather your information before you begin
- Consider all possible negative issues
- Think before speaking
- Avoid “no comment” or “off the record”
- Ask about the direction of the interview before you begin
- Know what your message is before you begin
- Use short responses (sound bites)
- If on camera, look at the reporter, not at the camera
- Use simple terms; avoid technical words
- Be honest; if you don’t know an answer, indicate that you don’t know
- Stress the positive or how things will improve in the future
- Dress appropriately
- Control the environment and your background
- Stay pleasant, calm and professional
- Remember to communicate your message

Guidelines for a News Briefing

- Control the briefing
- Maintain media interest by announcing time of next briefing
- Release new information at each briefing
- Advise the emergency officials who will be giving the briefing
- Agree on a signal for officials to end the news briefing
- Introduce the officials
- Lay down the ground rules to the media

Guidelines for Media Pools

- Agree on which PIO’s will lead the media pool
- Agree on approved area for the media with the IC
- Obtain a 4x4 vehicle if needed
- Have media personnel decide who will be picked from their medium
- If time permits, all media personnel can participate in the pool; have them pick numbers on who will go first
- Brief media personnel on emergency procedures and voice commands

Guidelines for Terrorist Incident(s)

- Brief the media that information will only be released from one information center
- Only certain information will be released, and will need approval of law enforcement
- Consider relocating the media sector or information center
- **No photo or videos will be allowed because of possible compromise of evidence**
- Expect extensive media interest (world-wide news coverage)
- Expect a federal agency to take over public information

Responsibilities of the Public Information Officer

- Establish a media sector and communicate its location
- Establish a Joint Incident Information Center
- Release warnings in the area, such as environmental hazards, evacuations, road closures, shelter information
- Generate news releases
- Conduct live TV and telephone interviews
- Arrange special request interviews
- Schedule news briefing and/or news conferences
- Provide escorts for VIPs
- Release information of critical services, such as food, water, medical care
- Release information on injuries and death counts
- Update new briefing
- Update Emergency Operation Center office
